### **NOTICE TO CLAIMANTS**

#### **What must I do after the items are seized?**

1. You may **apply** for any of the seized items to be returned to you **IF**
  - You own the items seized; and
  - You are not the Judgment Debtor/Execution Debtor in this action.
  
2. Even if you intend or are applying to claim any seized items you must not remove **either**
  - the court seals; or
  - any seized item from the present premises.

Action can be taken against you if you do so.

#### **How do I apply?**

3. Obtain a **Form 22** from the Sheriff's Counter at 2nd Level, Legal Registry, Supreme Court of Singapore. Typed this Form 22 neatly and filed this Form 22 at the Service Bureau (Monday – Friday 9.00am – 4.30pm / Saturday 9.00am – 12 noon) located on the 1st floor of Supreme Court of Singapore and pay the necessary fees. (CrimsonLogic Service Bureau tel no : 6337 9164 )

#### **Note for companies:**

If you are claiming as an incorporated company (eg. ABC Pte Ltd), you must filed this Form 22 through a lawyer.

#### **What happens after you have filed the Form 22?**

4. After filing Form 22, the Judgment Creditor will be asked by the Sheriff's Section to notify whether he admits or disputes you claim. If
  - **Your Claim is admitted.** The seized item(s) that is claimed will be released to you without you having to attend any court hearing.
  - **Your Claim is disputed.** When the relevant documents are prepared by the Sheriff's office and stamp fees are paid by the Judgment Creditor, service of the notified of a hearing date (**usually within 14 days**) to attend before a Judge. The relevant proceedings are termed Interpleader proceedings. If you did not turned up for the hearing your claim will be barred .
